## 3. GOFFS €50,000 BONUS SERIES

A €50,000 Bonus will be paid to the first 10 Orby graduates who win a nominated Two-Year-Old Maiden race throughout Ireland in the 2024 flat racing season. The nominated races will incorporate a diverse selection of Two-Year-Old

races across Ireland from the start of the 2024 flat season until Million Day at The Curragh. The nominated races will carry the €50,000 Goffs Bonus which will be paid to the winning connections.

A full list of eligible races will be published prior to the start of the 2024 flat racing season and will be paid on a first win - first paid basis to a maximum of 10 Bonuses.

In the event that all 10 Bonuses have not been won by Million Day the amount not won will be added to the Goffs Million and Goffs 500 prize money on a pro rata basis.

### Qualification

**A one-off qualification fee of €5,000 for the entire Two Million Series is payable at the point of purchase by ticking the box on the Acknowledgement of Purchase form.**

*(The qualification fee will be added to the Goffs invoice and is non-refundable once declared and paid. For horses not sold or bought back by the vendor the fee must be paid to Goffs to confirm eligibility).*

**NB The qualification fee is in addition to the race entry fees below.**

The Two Million Series is open to two-year-olds that were catalogued in the 2023 Orby Sale (Book 1 or Book 2), have paid the qualification fee and have been declared by Goffs as eligible including:

- Horses sold under the hammer or privately at the sale through Goffs
- Horses not sold or bought back by the vendor will qualify if the sale entry fee and full commission allowed in the Conditions of Sale is paid on the reserve price or Sale Price, whichever is the higher

- Where a sale is cancelled under the Conditions of Sale horses will qualify if the sale entry fee and full commission allowed in the Conditions of Sale is paid on the Sale Price
- Horses catalogued but withdrawn from the Orby Sale (Book 1 or Book 2) will qualify if they are subsequently catalogued and sold or bought back at the Goffs Autumn Yearling Sale

Payment must be made to Goffs within the terms laid out in the Conditions of Sale and Goffs reserves the right to declare the lot ineligible for entry into the race.

### Entry Fees to The Goffs Million and Goffs 500

- €5,000 to run (0.5% of the minimum prize fund for the Goffs Million or 1% for the Goffs 500)
- Entry will be to **BOTH** races and connections must only declare their preferred race at declaration stage.
- €5,000 via entry stages to Horse Racing Ireland
  - €2,000 to enter on 1<sup>st</sup> May 2024
  - €2,000 extra if forfeit not declared by 24<sup>th</sup> July 2024
  - €1,000 extra if forfeit not declared by 24<sup>th</sup> September 2024
- Entries will be accepted in accordance with the full conditions of the race as published in the Irish Racing Calendar, and must be made to Horse Racing Ireland (or Weatherbys for UK entries, France Galop for French entries)

- Horses which are not Named and Returned In Training with a Licenced Trainer by Wednesday 24th July 2024 will be automatically disqualified and removed from the race. (For Irish and British bred horses, trained in Ireland, an acceptable naming application should be made to HRI by Thursday, 18th July, 2024 at the very latest. For all other foreign bred horses, trained in Ireland, naming applications will take longer to process.)
- Maximum Runners: The 6 furlong and 7 furlong limit at The Curragh is 30. Should it be necessary to reduce the declared runners in either race to the maximum runners, or to such lesser number that the Stewards may decide, runners will be reduced by the elimination of those

horses which have not run. If further elimination is required the field will be reduced by the elimination of the horses that, in the opinion of the IHRB Handicappers, have the lowest adjusted ratings (having regard to the applicable sex allowance). International performances will be taken into account. The latest date for calculation of ratings is 10am on Tuesday 24<sup>th</sup> September 2024. The entry and forfeit fees paid to HRI (*totalling €5,000*) will be refunded to any horse eliminated due to excess numbers declared.
